DELAWARE STATE SENATE

151st GENERAL ASSEMBLY

SENATE BILL NO. 252

AN ACT MAKING APPROPRIATIONS FOR CERTAIN GRANTS-IN-AID FOR THE FISCAL YEAR ENDING JUNE 30, 2023; SPECIFYING CERTAIN PROCEDURES, CONDITIONS AND LIMITATIONS FOR THE EXPENDITURE OF SUCH FUNDS; AMENDING THE FISCAL YEAR 2023 APPROPRIATIONS ACT; AMENDING THE FISCAL YEAR 2023 ONE-TIME SUPPLEMENTAL APPROPRIATIONS ACT; AND AMENDING CERTAIN STATUTORY PROVISIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Three-fourths of all members elected to each house thereof concurring therein):

Section 33. *Section 1 of the Fiscal Year 2023 One-Time Supplemental Appropriations Act (Senate Bill 251 of the 151st General Assembly) provides an appropriation of \$3,933,000 for the Marijuana Control Act Contingency. Of this amount, \$1,000,000 shall be reallocated to the Department of State, Small Business, Delaware Economic Development Authority (20-10- 01) for the Entertainment Industry Fund. These funds shall be used to establish a pilot program providing incentives for the entertainment industry in the creation of media projects and digital interactive entertainment in Delaware.*

The Delaware Motion Picture and Television Development Commission (&Commission&), established under Section 8750A of Title 29 shall administer awards under this pilot program. Awards may reimburse up to 30% of production, preproduction, or postproduction expenditures incurred in the State that is directly used in a production activity of digital entertainment activity. The Commission may utilize up to \$50,000 of this amount for program administration. The Commission shall provide a report by June 1, 2023, to the Co-Chairs of the Joint Finance Committee on awards provided under this pilot program and recommendations for future program operations.
