AN ACT to make appropriations for the purpose of defraying the expenses of the state government for the fiscal years beginning July 1, 2021, and July 1, 2022, in the administration, operation and maintenance of the legislative, executive and judicial branches of the various departments, institutions, offices and agencies of the state; for certain state aid and obligations; for capital outlay, for the service of the public debt, for emergency and contingency; to repeal certain appropriations and any acts inconsistent herewith; to provide provisional continuing appropriations; and to establish certain provisions, limitations and restrictions under which appropriations may be obligated and expended. This act makes appropriations for the purposes described above for the fiscal years beginning July 1, 2021, and July 1, 2022.

Item 43. To the Tennessee Film, Entertainment and Music Commission from departmental revenues received by and interest earnings allocated to the commission. This appropriation is subject to approval by the Commissioner of Finance and Administration.

Item 57. To the Department of Economic and Community Development, Tennessee Film and Television Incentive Fund, pursuant to Tennessee Code Annotated, Section 4-3- 4903(e), the Commissioner of Finance and Administration is authorized to carry forward unexpended balances of any appropriations made for the incentive fund, and the unexpended grant balances of the Tennessee Entertainment Commission.
