SECTION 21. Section 44-31.2-11 of the General Laws in Chapter 44-31.2 entitled "Motion Picture Production Tax Credits" is hereby amended to read as follows:

## 44-31.2-11. Sunset.

No credits shall be issued on or after July 1, **2027 2029**, unless the production has received initial certification under § 44-31.2-6(a) prior to July 1, **2027 2029**.

SECTION 22. Section 44-31.3-4 of the General Laws in Chapter 44-31.3 entitled "Musical and Theatrical Production Tax Credits" is hereby amended to read as follows:

### 44-31.3-4. Sunset.

No credits shall be issued on or after July 1, 2027 2029, unless the production has received initial certification under § 44-31.3-2(c) prior to July 1, 2027 2029.
